RECENT DEFENSE VERDICTS AND OTHER RESULTS

- Achieved defense verdicts for a body donation company against 11 plaintiffs who claimed misrepresentation, intentional infliction of emotional distress, and mishandling of dead bodily remains.
- Obtained a defense verdict for a national trucking company and driver in claims stemming from a multiple-vehicle accident that occurred on Interstate 10 during a dust storm.
- Defended a shuttle bus driver who struck a pedestrian in an unloading zone at Phoenix Sky Harbor International Airport.
